Rocketry ("launch") activities are inherently dangerous and can pose significant risks to the Applicant, including, but not limited to: fire, explosion, errant high-speed projectiles or drones, and equipment and facilities malfunctions. These known risks are present at all times during the event and may result in personal injury or death. Unknown risks, such as the actions of other participants, guests, or visitors, may also result in personal injury or death. By signing below, you hereby acknowledge the inherently dangerous nature of the launch activities, and further acknowledge that you freely, voluntarily, knowingly, and expressly agree to assume full and complete responsibility for any and all such risks, whether known or unknown, associated with these activities.

2. Waiver of Liability

TV, its officers, members, volunteers, agents, sponsors, affiliates, vendors, and the TRA are not liable for any personal injury, wrongful death, property damage, or any and all other losses that may occur before, during, or after the event while Applicant remains on BLM land allocated to the event. This waiver applies regardless of whether the personal injury, wrongful death, property damage, or any other loss, is caused by negligence, drone activity, or any other act or omission. By signing below, you freely, voluntarily, knowingly, and expressly acknowledge and agree to the terms of this waiver.

3. Release and Hold Harmless

To the fullest extent allowed under Nevada law (and, if deemed applicable, the law of the state in which I reside), I, my estate, heirs, beneficiaries, executors, administrators, trustees, successors and assigns, personal and legal representatives, hereby release, waive, discharge, covenant not to sue, and hold harmless TV, its officers, members, volunteers, agents, sponsors, affiliates, vendors, and the TRA, from any and all liability for personal injury, wrongful death, property damage, and financial loss, and from any and all other claims, causes of action, liabilities, damages, costs, expenses, losses, judgments, or demands arising out of or related to my participation in or attendance at any TV event, whether caused by negligence, either active or passive, or any other cause.
